This worksheet is designed to assist you in organizing your receipts for Medical Expenses you incurred through the year. For your Medical Expenses to qualify as a deduction on your return all the categories below must exceed 10% of your adjusted gross income unless you or your spouse was born before January 2, 1951 then it is 7.5%.

**NOTE :** If you paid Medical Expenses for your deceased spouse or dependent, include them as Medical Expenses paid weather they were paid before or after the descent's death.

**What are Medical Expenses:** the cost of diagnosis, cure and cost for treatments affecting any part of the body. These expenses include payments for legal medical services rendered by physicians, surgeons, dentists and other medical practitioners. They include the cost of equipment, supplies, and diagnostic devices needed for these purposes. Medical care expenses must be primarily to alleviate or prevent a physical or medical defect or illness. Do not include expenses that are beneficial to general health, such as vitamins or a vacation unless prescribed by your doctor or physician.

Also included are Medical Premiums you pay for insurance that covers the expenses of medical care, and the amounts you pay for transportation to get medical care. Amounts paid for qualified long-term care services and limited amounts paid for any long-term care insurance contract are deductible as well. If any of these amounts are deducted through your payroll check and reported on your W-2 at the end of the year DO NOT include these amounts here so to prevent double reporting of these amounts.

Though all your amounts paid for medical must collectively total 10% or 7.5% or more of your adjusted gross income, they need to be separated into several categories for reporting purposes. *(see below)*
